**Russell Fields Prescribed Burn Unit** – Don Hagan, Assistant Professor, Clemson University; Helen Mohr, USFS, Forester Burn unit contains research plots for the JFSP-funded seasonality of burn study, FLN monitoring plots and a cane restoration study area.

State Line Prescribed Burn – Brian Browning, USFS, FMO, Nantahala Ranger District

Cooperative burn between the Sumter National Forest and the Nantahala NF – this burn unit spans 2 states and 2 national forests.

Garland Tract - Chris Holcomb, USFS, Wildlife Technician, Andrew Pickens Ranger District

Burn unit was historically an apple orchard and the apple trees were removed before the USFS purchased it in 1996. By 2001 SCDNR created what is known as the Long Creek Tract, which encompasses this unit. This special WMA is solely managed for small game habitat enhancement and has been kept in early successional stages with the use of prescribed fire on short rotations.

Turkey Ridge Burn Unit - Victor Wyatt, USFS, Sivliculturist, Andrew Pickens RD

Shortleaf restoration site where planted loblolly has been harvested and has been site prep burned and planted with shortleaf, Table Mountain and pitch pine species.

**Keowee Toxaway State Park and Burn Unit** – Caity Homan, SCSP, Biologist; Joe Lemeris SCDNR former SCSP Biologist; Michael Weeks, SCFC, West Unit Forester; Wes Bentley, USFS, AFMO Andrew Pickens RD

This burn was completed in conjunction with SC Forestry Commission. Hear about the SC State Parks burn program in the mountains of South Carolina.


Chattooga Belle Farm - Mr. Land, Owner of Chattooga Belle Farm
